# TERMS OF SALE

Bidder Number is Required to bid at Auction

**NOTICE** - These terms will be strictly adhered to.

Your vehicle will not be released until good negotiable U.S. Funds reach seller. ie: cash, certified or cashier's check, bank money order, or personal/company check accompanied by bank letter of credit.

1. All bidders must meet Auction Company credit requirements, which may include advance deposit before bidding. Auction Company reserves the right to refuse to register or to accept a bid from any person, corporation, partnership, joint venture, or other legal entity, which for any reason does not meet the sales terms or is deemed by G. Potter King as unacceptable.
2. All vehicles or items sold "as is/where is" unless seller makes guarantees. All guarantees are between buyer and seller and in writing and in no event shall Auction Company be responsible for correctness of warranties, or genuineness, or description of property.
3. Although statements prior to and during this sale by the Auction Company and auctioneer have come from what is thought to be reliable sources, purchaser must understand he is buying property entirely upon his own examination and opinion.
4. Unless sale of each item is advertised or announced otherwise, each lot is offered subject to reserve price of seller. All sales will be conducted according to the Uniform Commercial Code.
5. The auctioneer is bonded and licensed. Payment to sellers will be made according to the terms of this sale.
6. At the fall of auctioneer's hammer and after satisfactory payment by purchaser, ownership of lot passes to bidder designated by Auctioneer saying "sold" or otherwise declaring completion of sale. Thereupon the new owner assumes full responsibility of property he just bid for and agrees to the terms of this sale and further agrees to sign a confirmation of the purchase at the time of sale.
7. All articles, items or vehicles shall be removed from sale area by the purchaser at his expense following sale and if not removed, Auction Company may remove property to nearby housing with all expense of moving and storage at the expense of the purchaser.
8. Any cars settled for by approved sightdrafts or title attached checks will not be released until drafts have been paid by issuer's bank to the Seller.
9. If the foregoing conditions or any other applicable conditions herein are not complied with by purchaser and in addition to other remedies available to Auction Company and Consignor by law (including the right to hold purchaser liable for bid price) the Auction Company at its option may either do one of the following: cancel the sale and retain as liquid damages all payments made by purchaser, or resell the property at once following a public announcement at this Auction sale or any sale of its choice. In any such event the purchaser shall be liable for any deficiency of the resale plus all costs for such reselling including storage cost of both first and second sales, the Auction Company commission, and any or all costs incurred.
10. All bidders at auction must register for buyers number and have these terms in his possession as a requirement for bidding.
11. Any announcement made sale day takes precedent over printed matter regarding condition of cars and sale.
