ALL CUSTOMERS:

Agree that their space or spaces will be occupied during the entire nationally advertised show hours, in order to serve visiting buyers that attend the show. No deviation from the hours will be allowed. G.Potter King, Inc. d/b/a GPK Auctions reserves the right to modify the above schedule. Management will not be responsible to the applicant for any modification of the schedule.

EARLY EXIT POLICY:

Removal of vehicles (other than those sold) prior to the conclusion of the show is not permitted under any circumstances. All vehicle exit doors will remain closed until the show officially ends at 5:00pm on Sunday. By signing this contract I agree to be charged an early exit fee of \$500 if I do not adhere to this policy. I understand that there will be NO EXCEPTIONS.

APPLICANT'S AGREEMENT:

In consideration of the disclosed fee and the meeting of all terms set by GPK Auctions, I do agree to rent the agreed upon space at the Atlantic City Classic Car Auction. It is agreed by both parties that the rental of this space does not in any way make the seller responsible for any commissions. I agree to rent such space with the express agreement that I will be permitted to sell the disclosed vehicle or vehicles at a price determined by me, and that GPK Auctions has no responsibility for the sale of said vehicle or vehicles.

I agree to hold harmless GPK Auctions for any responsibility in the sale of said vehicle or vehicles. GPK Auctions is not part of any agreement of any kind between the buyer and seller.

MANAGEMENT'S RULES:

Any conduct or actions deemed to be unethical in the judgment of Management or any infractions of this agreement on the part of the exhibitor, employees, or representatives of an exhibitor will subject to dismissal and eviction from the exhibit area. The applicant agrees to remove any displays prohibited by Management. In the event of any removal or dismissal under this paragraph, it is agreed that Management will not be liable to the applicant for any damages or expenses incurred. Any expulsion or exclusion of the applicant will be in addition to any other legal rights that Management may have arising out of any breach of this agreement.

ALLOCATION OF SPACES:

This application is subject to acceptance by GPK Auctions. Space is allocated on a first-come first-served basis; however, GPK Auctions reserves the right to exclude any applicant if in the opinion of Management such exclusion is in the best interest of the show. GPK Auctions reserves the right to determine floor location. Space sharing or subletting is not permitted.

PASSES:

Exhibitors shall receive two (2) passes (per space purchased). Additional tickets are available at one half the current ticket fee and may be ordered in advance or purchased from GPK Auctions.

TITLE:

Applicant agrees to provide to buyer a good and clear title at the time of sale as part of this agreement. In the event the Title is encumbered in any way, assigned, pledged chattel mortgage, or security agreement, I will present to buyer a written consent of the holder of said encumbrance or security interest to sell the vehicle.

I herein release GPK Auctions of any such responsibility for such title or liens against and agree to hold GPK Auctions harmless in the event of any lawsuit filed by the buyer. I also agree to pay all fees and costs incurred by GPK Auctions in the event of any court or legal action resulting from said sale of my vehicle or vehicles.

VEHICLE REPRESENTATION:

Applicant declares that the authenticity, history and condition of the vehicle, as stated in this agreement, is accurate and true. Seller agrees to hold harmless GPK Auctions and all its employees for any misrepresentation of vehicles sold at GPK Auctions events.

LIABILITY / PROPERTY INSURANCE / PERSONAL INJURIES / OTHER DAMAGE:

Management assumes no responsibility whatsoever for any property in the Convention Center. The applicant agrees to indemnify and hold Management harmless and hereby expressly releases and discharges Management from any and all liability for any loss, injury, suits or damage to person or property that may be sustained by reason of the occupancy of the Convention Center under this agreement. The applicant agrees to maintain its own casualty insurance covering any property used or to be located at the Convention Center. The applicant further agrees to purchase and maintain general public liability insurance covering any liability which may arise out of its occupancy of space in the Convention Center. Upon request, the applicant will exhibit proof of this insurance to Management. Failure of Management to inspect applicant's insurance policy shall in no way be deemed a waiver of this requirement.
