ALL CUSTOMERS:

Agree that their exhibit space or spaces will be open for business, with merchandise uncovered for display and sale, and with sales persons in attendance during the entire above listed and nationally advertised show hours, in order to serve visiting buyers that attend the show. No deviation from the hours will be allowed. G. Potter King, Inc. d/b/a GPK Auctions reserves the right to modify the above schedule. Management will not be responsible to the applicant for any modification of the schedule.

EARLY EXIT POLICY:

Dismantling of displays or removal of exhibitor vehicles or merchandise (other than items sold) prior to the conclusion of the show is not permitted under any circumstances. All vehicle exit doors will remain closed until the show officially ends at 5:00pm on Sunday. By signing this contract I agree to be charged an early exit fee of \$500 if I do not adhere to this policy. I understand that there will be NO EXCEPTIONS.

APPLICANT'S AGREEMENTS:

The applicant agrees to use and occupy its exhibit space in a safe and careful manner, and to comply with all laws, rules, regulations and ordinances which may apply, as well as all rules and regulations relating to the use of the Center and GPK Auctions. The applicant further agrees not to do any act or allow any act to be done which will in any way mar, deface or injure any part of the Convention Center. The applicant agrees to be responsible for any damage to walls, ceilings, pillars, etc. in its rental area which result from the use of nails, screws, tape, glue or any materials that may cause damage to these areas. At the conclusion of the show, the applicant will deliver to GPK Auctions the premises in as good condition and repair as they were at the beginning of the applicant's occupancy of the rented space. The applicant further agrees not to allow any loud speaking sound displays. No soliciting for business shall be permitted in aisles or other exhibitors' booths. Samples, catalogs, pamphlets and other publications may only be distributed by exhibitors strictly within the confines of their own booth.

MANAGEMENT'S RULES:

Any conduct or actions deemed to be unethical in the judgment of Management or any infractions of this agreement on the part of the exhibitor, employees, or representatives of an exhibitor will subject to dismissal and eviction from the exhibit area. The applicant agrees to remove any displays prohibited by Management. In the event of any removal or dismissal under this paragraph, it is agreed that Management will not be liable to the applicant for any damages or expenses incurred. Any expulsion or exclusion of the applicant will be in addition to any other legal rights that Management may have arising out of any breach of this agreement.

ALLOCATION OF SPACES:

This application is subject to acceptance by GPK Auctions. Space is allocated on a first-come first-served basis; however, GPK Auctions reserves the right to exclude any applicant if in the opinion of Management such exclusion is in the best interest of the show. GPK Auctions reserves the right to determine booth location. Space sharing or subletting is not permitted.

PASSES:

Exhibitors shall receive two (2) vendor passes (per space purchased). Additional tickets are available at one half the current ticket fees and may be ordered in advance or purchased from GPK Auctions.

UTILITIES, ETC.:

Fees paid by the applicant shall include the use of the space, all overhead lighting, heating and cleaning of aisles, entrances and corridors. Additional facilities or personnel other than provided by this contract are available at current Convention Center rates. Exhibitor is responsible for cleaning their own space at completion of event. Exhibitor must remove all trash from their booths.

LIABILITY / PROPERTY INSURANCE / PERSONAL INJURIES / OTHER DAMAGE:

Management assumes no responsibility whatsoever for any property in the Convention Center. The applicant agrees to indemnify and hold Management harmless and hereby expressly releases and discharges Management from any and all liability for any loss, injury, suits or damage to person or property that may be sustained by reason of the occupancy of the Convention Center under this agreement. The applicant agrees to maintain its own casualty insurance covering any property used or to be located at the Convention Center. The applicant further agrees to purchase and maintain general public liability insurance covering any liability which may arise out of its occupancy of space in the Convention Center. Upon request, the applicant will exhibit proof of this insurance to Management. Failure of Management to inspect applicant's insurance policy shall in no way be deemed a waiver of this requirement.
