## TERMS OF CAR CORRAL & CAR CANOPY CONTRACT

In consideration of the disclosed fee and the meeting of all terms set by G. Potter King, Inc., I do agree to rent the agreed upon space at the Atlantic City Classic Car Auction.

It is agreed by both parties that the rental of this space does not in any way make the seller responsible for any commissions. I agree to rent such space with the express agreement that I will be permitted to sell the disclosed vehicle or vehicles at a price determined by me, and that G. Potter King, Inc. has no responsibility for the sale of said vehicle or vehicles.

I agree to hold harmless G. Potter King, Inc. for any responsibility in the sale of said vehicle or vehicles. G. Potter King, Inc. is not part of any agreement of any kind between the buyer and seller.

I further agree that we will provide to buyer a good and clear title at the time of sale as part of this agreement. In the event the Title is encumbered in any way, assigned, pledged chattle mortgage, or security agreement, I will present to buyer a written consent of the holder of said encumbrance or security interest to sell the vehicle.

I herein release G. Potter King, Inc. of any responsibility for such title or liens against and agree to hold G. Potter King, Inc. harmless in the event of any law suit filed by the buyer. I also agree to pay all fees and costs incurred by G. Potter King, Inc. in the event of any court or legal action resulting from said sale of my vehicle.

I herein represent the authenticity, history and condition of the vehicle as I have stated in this agreement, is accurate and true. Seller agrees to hold harmless G. Potter King, Inc. and all its employees for any misrepresentation of all and any vehicles sold at G. Potter King, Inc. events.

## TERMS OF CAR SALON/SPECIALTY CAR SPACE CONTRACT

Spaces are rented for the 4 days of the event. Fees cover space and/or one (1) run through the auction. G. Potter King, Inc. offers the vehicle for sale with the consent of the seller at a price determined by the seller. G. Potter King, Inc. reserves the right to refuse a rental space if on agreement the value of vehicle is not acceptable to G. Potter King, Inc.

Seller agrees to provide accurate history of vehicle and is sole responsible for all descriptions of vehicle.

G. Potter King, Inc. in no way offers the vehicle for sale. Rather, it represents the seller and does not have a knowledge of vehicle other than that presented by seller.

Auction is conducted by licensed auctioneer, not an employee of G. Potter King, Inc.

Seller agrees to hold harmless G. Potter King, Inc., in any and all lawsuits or disputes resulting from sale of any vehicle.

To reserve space in the Car Salon or Specialty Car area. Seller agrees to pay a commission to G. Potter King, Inc. plus an agreed upon rental fee.

Seller agrees to provide a clear, unencumbered title at time of registration. No vehicle is permitted in salon unless title is presented.
